Title 69 O.S. §1275 3(c) prohibits signs from being located within 500 feet of a playground. An excerpt from the statutes has been enclosed.

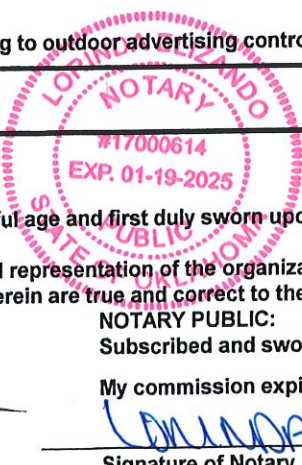
