This letter is to notify you that recently when in the area, the above-referenced advertising structure was found to be illegal pursuant to the Federal Highway Beautification Act and the Oklahoma Outdoor Advertising Control Act. According to County Assessor records it appears you are the owner of the property upon which the sign is located. The sign is located on the east side of US-69, approximately 5.8 miles south of SH-165. A photo of the sign has been enclosed for your review.

This sign has been determined to be illegal due to not being registered with the Department of Transportation (Registration requires a permit application process to be completed) The Statutes and Regulations regarding control of outdoor advertising are found in Title 69 O.S. 2011 1271-1288, as amended, and Title 730:35-5 of the Oklahoma Administrative Code. For sign application forms and information visit our website at www.ok.gov/odot - doing business - Outdoor Advertising Signs.

At this time we respectfully request that the structure be brought into compliance by a responsible party by obtaining a Class "A" permit, if regulations can be met, or removing it within 90 days of receiving this notice. Please be advised that failure to take appropriate action shall result in legal action being taken for which you shall be assessed both the legal fees and the costs of removal if the State is required to remove the sign.

On June 27, 2019, a notice was sent to you advising the above-referenced advertising sign was determined to be illegal pursuant to the Oklahoma Outdoor Advertising Control and Federal Highway Beautification Acts. (A copy of the letter has been enclosed for your review.) The notice informed you the sign had been deemed illegal due to not being registered with the State of Oklahoma, and would need to be registered or removed within ninety (90) days of receipt of the notice. The notification also included a "Response Sheet" for you to complete if you disagreed with the illegal determination.

As of today's date we have not received a permit application with which to register the sign nor any evidence the sign has been removed. This letter is to merely serve as a courtesy reminder of the impending deadline which is September 29, 2019.



On June 27, 2019, a notice was sent to you advising the above referenced advertising sign was determined to be illegal pursuant to the Oklahoma Outdoor Advertising Control Act. On August 26, 2019 a second letter was sent giving you thirty days to bring the sign into compliance. (The sign is located on the east side of US-69, approximately 5.8 miles south of SH-165.)

The sign was determined to be illegal due to not being registered with the State of Oklahoma. The timeframe prescribed to either register or remove the sign expired on September 29, 2019. On September 30, 2019 an inspection was made of the site and we found the sign to still be in place. (A photo of the sign has been enclosed along with copies of all correspondence referenced in this letter.)

As of today's date no action has been taken to rectify the situation. Therefore, in accordance with both Federal Statutes and Oklahoma Law, the file is now being forwarded to the Department's Legal Division for legal action.
