Form OAC 1-504 I spoke with Russell Holland, he thought the property he saw. The SOA was for a different property.

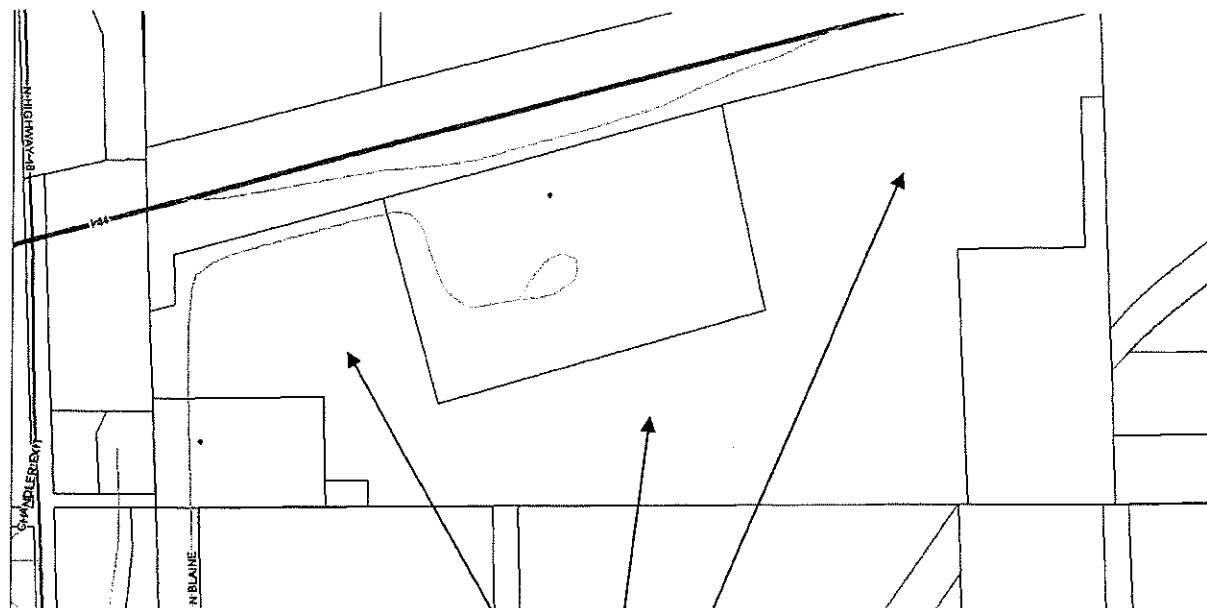
Entered into Public Hearing at 5:26 p.m.
