This is to notify you that during a recent inspection, the above-referenced advertising structure was determined to be illegal pursuant to the Federal Highway Beautification Act and the Oklahoma Outdoor Advertising Control Act. The sign is located on the south side of US-70, approximately 4 miles east of US-81. A photo of the sign has been enclosed for your review.

This sign has been determined to be illegal due to not being registered with the Department of Transportation. (Registration requires a permit application process to be completed.) The Statutes and Regulations regarding control of outdoor advertising are found in Title 69 O.S. 2011 1271-1288, as amended, and Title 730:35-5 of the Oklahoma Administrative Code. If you would like a copy of these rules and regulations or any requisite application forms, please contact this office and a packet can be mailed to you or you can visit our website at www.ok.gov/odot - doing business - Outdoor Advertising Signs.

At this time we respectfully request that the structure be brought into compliance by a responsible party by obtaining a Class "A" permit, if regulations can be met, or removing it within 90 days of receiving this notice. Please be advised that failure to take appropriate action shall result in legal action being taken for which you shall be assessed both the legal fees and the cost of removal if the State is required to remove the signs.

On February 6, 2019, a notice was sent to you advising the above-referenced advertising sign was determined to be illegal pursuant to the Oklahoma Outdoor Advertising Control and Federal Highway Beautification Acts. On February 6, 2019, a notice was sent to you advising the above referenced advertising sign was determined to be illegal pursuant to the Oklahoma Outdoor Advertising Control Act. On April 9, 2019 a second "official" notice was sent reminding you of the impending due date to bring the sign into compliance. (The sign is located on the south side of US-70, approximately 4 miles east of US-81.)

The sign was determined to be illegal due to not being registered with the State of Oklahoma. The timeframe prescribed to remove the sign expired on May 8, 2019. On May 13, 2019 an inspection was made of the site and we found the sign to still be in place. 




