Dear Mr. Selcer:

Last year SH-51 in Wagoner County where the above-referenced signs are located, was officially accepted by the Federal Highway Administration as part of the National Highway System (NHS.) As you are aware, all outdoor advertising signs adjacent or advertising to routes of highways that are part of the NHS, are required to be registered with the Department of Transportation. June 9th an inventory of signs was taken along the subject route. Signs that were in existence were photographed and documented. A current photo of the sign structures has been enclosed for your review.

Currently, we are notifying the owners of these signs to register them with the Department of Transportation. We have enclosed the proper application forms necessary to register these signs. If the sign can meet current Class "A" requirements, then a Class "A" Permit will be issued. However, if it cannot, then a Grandfathered or Legal Non-conforming status can be assigned as long as the sign type or structure has not been altered since the inventory. An Application for Sign Registration for each type of registration has been enclosed for your use. Please make copies if needed.

If you are the owner of these signs, please complete the enclosed application form for each sign, and submit it along with required items to this office within ninety (90) days of receiving this letter. If you are not the owner of this sign, then please contact our office as soon as possible.
