Our client, Zoom Capital, LLC owns a perpetual easement for the benefit of leasing space for the use/operation of a Billboard on Oklahoma County parcel 14-087-5240. The property is located at the northwest corner of the Interstate 44 & Interstate 35 Interchange where Interstate 44 heads west from Interstate 35.

Lamar Outdoor Advertising was our client's tenant and operated a billboard on the easement under ODOT Registration # 11601. Recently, a pending ODOT project required the removal of the billboard. As such, ODOT negotiated with Lamar for the removal of the billboard structure and Lamar terminated its lease with our client. Lamar's billboard structure has been removed from the property.

Enclosed are the following documents for your files and review (i) Perpetual Easement Agreement and Assignment of Lease recorded in the land records of Oklahoma County, (ii) August 19, 2020 lease termination letter from Lamar to Zoom Capital, (iii) ODOT's Tenant Release and Summary of Acquisition confirming the removal of Lamar's sign from the property.
