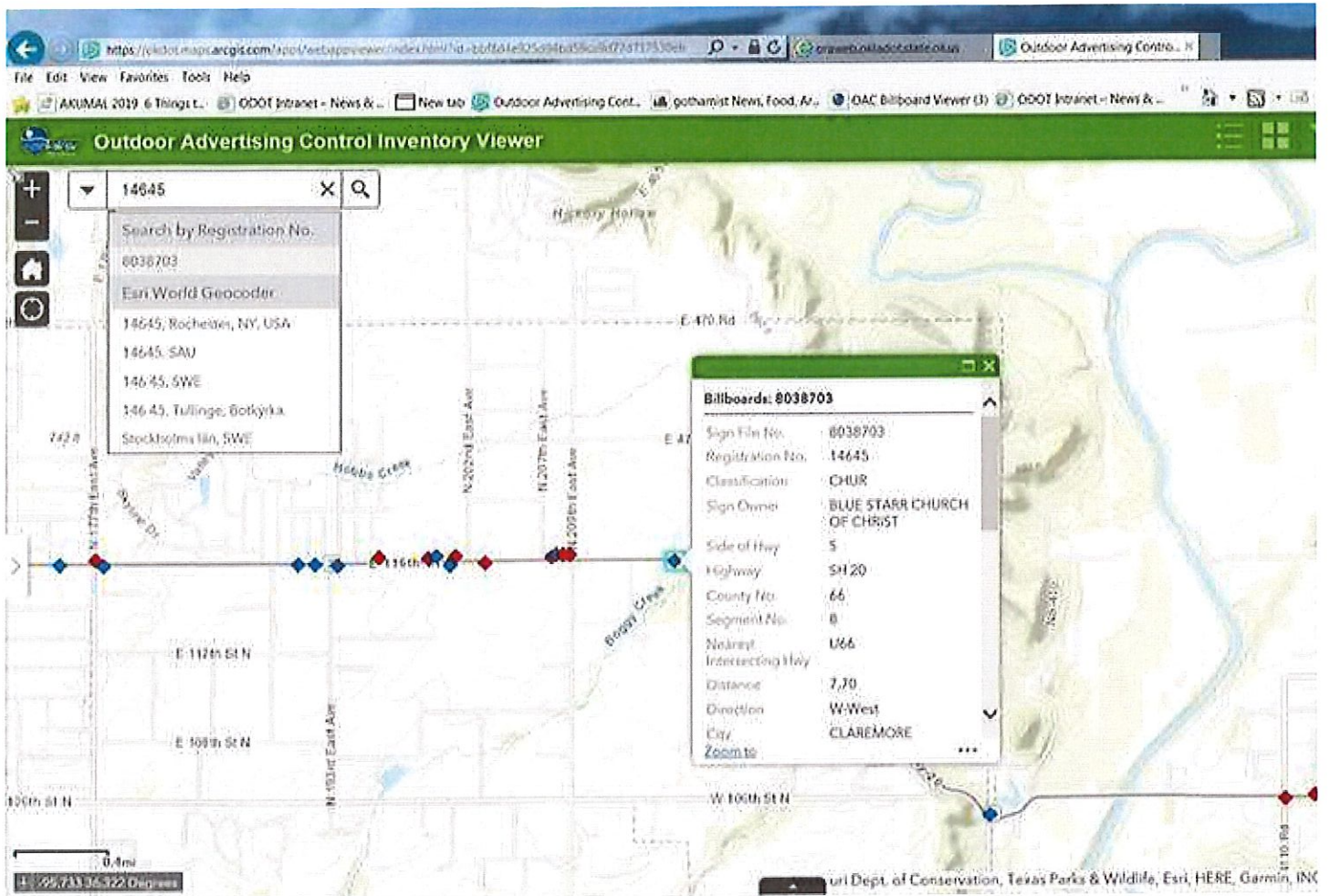
Keith,
